Raj HC ordered to provide home-made food and other necessary medical treatment to Sant Shri Asaram ji Bapu.

Further, this is to be abhorred and strongly condemned about Rajasthan Govt's hostile and inhuman behavior towards him for opposing it to provide home-made food which intensified further by state's casual response on ignoring proper medical treatment for him. Is the state playing a part in conspiracy against him? Let CM Vasundhara Raje to speak upon this.

In a writ petition filed against various state government departments including the state home department and the directorate of prisoners, Rajasthan High Court gave order to provide home-made food and other necessary medical treatment to Sant Shri Asaramji Bapu.

The petition which was filed on behalf of Bapuji by Hindu Vididany Parishad -an association of lawyers for Pro-Hindu Issues and SAFSAC - an organization belonging to his followers, raised the issue about outrageous behavior towards Bapuji by jail administration which is not even treating as a commoner. Further, it was brought in HC's notice why sessions court order more than three months ago for providing Ayurvedic treatment and prescribed food to Sant AsharamJi Bapu was not being implemented.

From Hindu Vididanya Parishad for Sant AsaramJi Bapu, Advocate Rajeev K Panday and Advocate Sanjiv Punalekar contested that in view of Sant AsaramJi Bapu's deteriorating health the board of Ayurvedic doctors, constituted after session court order, prescribed selected food to him. But this direction of the Ayurvedic experts is not being complied with and the petitioner had to consume whatever is being served to him. This further deteriorated the health and moral of the petitioner.

"If home-made food can be allowed to Tehelka chief Tejpal and Ex-minister Babulal Nagar, then why it cannot for Bapuji where his life has a public importance? The legitimacy of basic fundamental rights is being totally ignored here. We were just demanding not more than food prescribed to preserve his health deteriorating day by day and it was just for name-sake that state was providing the medical treatment to him. Then what is worth to keep continue this medical treatment if there is a fall in his health as the same is also evident in favor by medical reports. It was order by the sessions court before three months ago to provide Ayurvedic treatment to him. After then it was not followed by Jail Administration and only two-three medical check-ups facilitated just for sake of the medical treatment. Further, this also comes out in a hesitant response by Dr. Sarvapalli Radhakrishnan Ayurvedic Vishwavidyalaya's doctors, from where aforesaid medical board was constituted, while replying on why not prescribing for him the admission in a hospital or an Ayurvedic dispensary outside the jail as it gets reflected abnormal in medical reports, the lawyers of petitioner said."

"The petitioner's health is deteriorating more or less in the manner where a person advances towards ill health through slow-poisoning in so far as the denial of treatment of various ailments coupled with denial of medicated food is creating an adverse and irreversibly damaging impact whereby finally the petitioner is liable to collapse and be compelled to seek only Allopathic treatment for his life saving, they added further"

"It seems that state itself is a part of conspiracy as after public prosecutor was emphasizing on refusal to provide home-made food or allow only for single time in a day. Further, he tried to seek to get more time as always he gets to keep the hearing extended. This was forth times after the period of more than a month when petition was heard. If the petitions for such small compliances would be filed to claim the basic rights, then state of the law in the state is at bottom most level, as strongly raised by spokespersons of SAFSAC." It has been observed in case of Sant Shri Asaramji Bapu to keep extending the arguments and verdicts for the date after the dates.

On other side, demand for the speedy trial after seeing a lot of extension of the arguments and date after the dates in this case, the million anguish voices are consistently rising up in the form of tweets with various trends
